**Guidelines for Usage of the Primitive Campsites  
at the Mineola Nature Preserve on the Sabine River**

1. The primitive campsites can be reserved by calling Mineola City Hall (903) 569-6183. For emergency access after hours contact Mineola Police Department 911 (Emergency) or Police Dept. (903) 569-6294.
2. **There will be a \$5.00 Per Day User Fee required. Please make check to the Mineola Nature Preserve. Mail to: P. O. Box 179 Mineola, TX 75773 or leave in drop box at information booth at the Derby located at 4429 SE Loop 564.**
3. Please, **DO NOT LITTER.**
4. **ANY and ALL trash should be bagged and picked up in and around the camping space.**
5. **NO BICYCLES (unless on approved biking trails), ROLLERBLADES OR SKATEBOARDS WILL BE PERMITTED at the Mineola Nature Preserve.**
6. **NO LOUD MUSIC** except with approval from City of Mineola (903-569-6183) and during the special events.

**Release and Waiver.** Participant does hereby release and forever discharge and hold harmless City of Mineola ("City") from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participant's use of the facility. Participant understands that this release discharges City from any liability or claim that the participant may have against City with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the use of the facility whether caused by the negligence of City.
